[What are your data protection rights?](#)

Every user is entitled to the following:

*The right to access* – You have the right to request Unicis for copies of your personal data. We may charge you a small fee for this service.

*The right to rectification* – You have the right to request that Unicis correct any information you believe is inaccurate. You also have the right to request Unicis to complete the information you believe is incomplete.

*The right to erasure* – You have the right to request that Unicis erase your personal data, under certain conditions.

*The right to restrict processing* – You have the right to request that Unicis restrict the processing of your personal data, under certain conditions.

*The right to object to processing* – You have the right to object to Unicis’s processing of your personal data, under certain conditions.

*The right to data portability* – You have the right to request that Unicis transfer the data that we have collected to another organization, or directly to you, under certain conditions.

If our website contains links to other websites. Our privacy policy applies only to our website, so if you click on a link to another website, you should read their privacy policy.

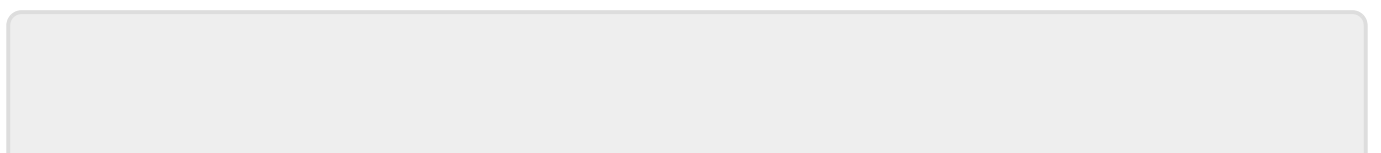
